PRIVILEGES FOR MANAGEMENT COMMITTEE

INTRODUCTION

1. SAF Yacht Club (SAFYC) Management Committee (MC) members play an important role in the governance of the Club's overall well-being. In recognition of their valuable contributions, the Club accords privileges to these MC Members. The below privileges were reviewed in MC Meeting on 26 Oct 2024

AIM

2. The aim of this policy is to stipulate the privileges accorded to the members of the Management Committee.

PRIVILEGES

- 3. Each member of the MC, regardless of appointment, is entitled to the privilege listed below:
 - a. Complimentary Charter of Powerboat.
 - 1) One complimentary 4 hours "bareboat"* charter once a month (subject to availability and not applicable during major events).
 - 2) It does not include skipper fees and fuel charges.
 - 3) MC Members can top-up the difference for chartering of cruises.
 - 4) The pre-arranged complimentary booking by the MC member may be subjected to cancellation if there is a paying member requesting to charter the same craft.
 - 5) The MC member must possess the necessary qualification or proficiency to operate the craft they intend to charter.
 - b. Complimentary usage of Private Suite.
 - 1) Each MC member is entitled to one-night complimentary stay in the private room once every 6 months during the off peak period.
 - 2) For peak and super peak period stay, MC members are required to top up the difference accordingly.
 - *Bareboat charter refers to Diana/Power 1 -20ft powered boat c/w 60hp 4 stroke OBM equivalent
 - 3) Each MC member may only make the booking 2 weeks in advance (subject to availability).

- 4) At any time, only 1 private room is made available for MC member's complimentary usage.
- 5) The MC member is required to be present at the time of check-in.
- 6) The management of SAFYC reserves the right to cancel the booking should there be any unforeseen circumstances due to business operation requirements.
- c. Complimentary usage of BBQ pit.
 - 1) Each MC member is entitled to one complimentary usage of BBQ pit at designated area once every quarter (subject to availability).
 - 2) The MC member is required to be present at the time of usage.
 - 3) The management of SAFYC reserves the right to cancel the booking should there be any unforeseen circumstances due to business operation requirements.

TERMS AND CONDITIONS

- 4. The privileges listed above are governed by the following terms and conditions:
 - a. They are non-accumulative, not transferable or exchangeable for other privileges.
 - b. To be eligible for these privileges, the MC members must attend at least 3 MC meetings per term.
